

ORDINANCE NO: 16-10

AN ORDINANCE AMENDING CHAPTER 7, SCHEDULE XXII OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF KEYPORT WITH REGARD PARKING TEMPORARILY PROHIBITED FOR SNOW REMOVAL

WHEREAS, pursuant to *N.J.S.A. 40:48-1*, the power to adopt public ordinances for public health, safety and welfare of the Borough is conterminous with the power of the legislature; and

WHEREAS, it has been determined by the Mayor and Council of the Borough of Keyport that it is necessary to amend temporarily prohibited parking for snow removal to prohibit any vehicle from being parked on certain streets or highways or portions thereof when snow has fallen such that it covers the street or highway; and

WHEREAS, the Mayor and Council of the Borough has determined that the current Schedule should be supplemented to include additional streets as part thereof; and

WHEREAS, the Mayor and Council of the Borough of Keyport wish to supplement Schedule XXII of Chapter Seven of the Revised General Ordinances of the Borough of Keyport, which governs parking temporarily prohibited for snow removal, to effectuate the same.

NOW THEREFORE, BE IT ENACTED by the Mayor and Council of the Borough of Keyport that:

Chapter Seven, Schedule XXII is supplemented as follows:

<u>Street</u>	<u>Side</u>	<u>Location</u>
<u>Warren Street</u>	<u>North</u>	<u>Main Street to Division Street</u>
<u>Division Street</u>	<u>East</u>	<u>Hurley Street South to Union Street</u>
<u>Osborn Street</u>	<u>East</u>	<u>Union Street North to Hurley Street</u>
<u>Provost Street</u>	<u>North</u>	<u>Broadway Street West to Dead End</u>
<u>Chandler Street</u>	<u>North</u>	<u>Broadway Street West to Dead End</u>
<u>Oak Street</u>	<u>South</u>	<u>Spring Street East to Walnut Street</u>

All other Street regulations not affected by this Ordinance remain in full force and effect. All other streets and locations listed in Schedule XXII should not be affected.

If any part or parts of the Ordinance are for any reason held to be invalid, such adjudication shall not affect the validity of the remaining portions of this Ordinance.

All Ordinances or parts of Ordinances which are inconsistent herewith are repealed, but only to the extent of such inconsistency.

This Ordinance shall become effective immediately upon its final passage and publication as required by law.
