

## **ORDINANCE NO: 17-10**

### **AN ORDINANCE AMENDING CERTAIN CHAPTERS OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF KEYPORT TO DECREASE CERTAIN FEES EFFECTIVE JANUARY 1, 2011**

**WHEREAS**, pursuant to *N.J.S.A. 40:48-1*, the power to adopt public ordinances for public health, safety and welfare of the Borough is conterminous with the power of the legislature; and

**WHEREAS**, **Ordinance 4-10** (An Ordinance Amending Chapter 12-1 of the Revised General Ordinances of the Borough of Keyport with Regard to Backflow Prevention Devices Inspection Fees), **Ordinance 7-10** (An Ordinance Amending Chapter 12-1 of the Revised General Ordinances of the Borough of Keyport with Regard to Subcode Fees), **Ordinance 8-10** (An Ordinance Amending Chapter 12-2.3 of the Revised General Ordinances of the Borough of Keyport with Regard to Certificate of Occupancy) **Ordinance 9-10** (An Ordinance Amending Chapter 12-14.7 of the Revised General Ordinances of the Borough of Keyport with Regard to Landlord Registration Fees) increased certain fees due to the Borough; and

**WHEREAS**, the Mayor and Borough Council wish to repeal the aforementioned Ordinances so that all fees amended by such Ordinances are reinstated to the level they were prior to the effective date of such Ordinances.

**NOW THEREFORE, BE IT ENACTED** by the Mayor and Council of the Borough of Keyport that:

**Ordinance 4-10** (An Ordinance Amending Chapter 12-1 of the Revised General Ordinances of the Borough of Keyport with Regard to Backflow Prevention Devices Inspection Fees), **Ordinance 7-10** (An Ordinance Amending Chapter 12-1 of the Revised General Ordinances of the Borough of Keyport with Regard to Subcode Fees), **Ordinance 8-10** (An Ordinance Amending Chapter 12-2.3 of the Revised General Ordinances of the Borough of Keyport with Regard to Certificate of Occupancy) **Ordinance 9-10** (An Ordinance Amending Chapter 12-14.7 of the Revised General Ordinances of the Borough of Keyport with Regard to Landlord Registration Fees) are hereby repealed.

Any fees increased by Ordinance 4-10, Ordinance 7-10, Ordinance 8-10 and Ordinance 9-10 shall be reduced to the level they were prior to the effective date of that Ordinance.

Any fees collected by the Borough from the effective dates of Ordinance 4-10, Ordinance 7-10, Ordinance 8-10 and Ordinance 9-10, respectively, to the effective date of this Ordinance \_\_\_\_-10 shall not be affected.

Attached hereto are Ordinance 4-10, Ordinance 7-10, Ordinance 8-10 and Ordinance 9-10 and shall be incorporated herewith.

If any part or parts of the Ordinance are for any reason held to be invalid, such adjudication shall not affect the validity of the remaining portions of this Ordinance.

All Ordinances or parts of Ordinances which are inconsistent herewith are repealed, but only to the extent of such inconsistency.

This Ordinance shall become effective on January 1, 2011.
