## **ORDINANCE #4-15**

## AN ORDINANCE AMENDING AND SUPPLEMENTING AN ORDINANCE FIXING THE SALARIES OF THE VARIOUS OFFICERS, CLERKS AND EMPLOYEES OF THE BOROUGH OF KEYPORT, COUNTY OF MONMOUTH, STATE OF NEW JERSEY

WHEREAS, it is the desire and intent of the Mayor and Council of the Borough of Keyport to have prepared and adopt a salary ordinance which will have properly served their purposes, and

WHEREAS, the following Ordinance has been prepared with salary ranges therein for the positions listed, wherein the ranges give the minimum salary for the position as well as the maximum for the position, and the exact salary to be paid to each employee as determined by a Resolution duly adopted by the Mayor and Council of the Borough of Keyport must be within the ranges given in the Ordinance.

**NOW, THEREFORE, BE IT ORDAINED,** by the Mayor and Council of the Borough of Keyport, County of Monmouth State of New Jersey as follows:

## PLEASE NOTE THAT ALL OF THE FOLLOWING ARE NOT INCREASES IN EXISTING SALARIES, BUT ARE RANGES WITHIN WHICH SALARIES MUST FALL.

Salary Minimum – Maximum

Municipal Court Judge	\$10,000 - \$30,000
Municipal Prosecutor	\$10,000 - \$25,000
Public Defender	\$ 5,000 - \$10,000
Court Administrator	\$35,000 - \$70,000
Deputy Court Administrator	\$15,000 - \$40,000
Violations Clerk	\$15,000 - \$40,000
Administrative Secretary	\$39,000 - \$60,000
Technical Assistant to the Construction Official (TACO)	\$30,000 - \$60,000

rechnical Assistant to the Construction Official (TACO) \$30,000 - \$60,000

Inconsistent Ordinance. All Ordinances are parts thereof inconsistent with the provisions of this Ordinance are hereby repealed as to such inconsistency.

Severability. If any section, paragraph, subdivision, shall be adjudged invalid, such adjudication shall apply only to the section paragraph, subdivision, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid effective.

Effective Date. This Ordinance shall take effect upon its passage and publication according to law except that portion as it pertains to managerial, executive or confidential employees which shall become operative in 20 days after the publication thereof, after final passage, unless within said 20 days a petition signed by the voters equal in number to at least 5% of the registered voters protecting against the passage of such Ordinance being presented to the Governing Body.
